



Christian Network Service Agreement

This Agreement is entered into as of the ____ day of _____, 2010 between Christian Network and (Print Your Name) _____.

Subject to the terms and conditions of this Agreement, Christian Network agrees that we will not disclose your design and work directly or indirectly, or use in any manner during the term of this Agreement or at any time thereafter, except as required in the course of this engagement, for marketing, promotion to promote and locate resources for your ministry, organization, or service.

Conflicts of Interest: Non-hire Provision

Christian Network represents that we are free to enter into this Agreement and that this engagement does not violate the terms of any agreement between Christian Network and any third party. Further, Christian Network, in rendering their duties shall not utilize any invention, discovery, development, improvement, innovation, or trade secret in which they do not have a proprietary interest. During the term of this agreement, Christian Network shall devote their productive time, energy and abilities to the performance of their duties hereunder as is necessary to perform the required duties in a timely and productive manner. Christian Network is expressly free to perform services for other parties while performing your services.

Non-compete: Non-interference

During the course of this Agreement and for a period of 12 months immediately following the expiration or termination of this Agreement for any reason, you will not, either directly or indirectly, solicit Christian Network clients or interfere with Christian Network contracts or prospective relationships. If there are any clients with whom you have a pre-existing relationship, they are specifically excluded from this section.

Termination

This Agreement may be terminated at any time by 10 working days' written notice/ e-mail to Christian Network. In addition, if you are involved or convicted of any crime or offense, fail or refuse to comply with the written policies or reasonable directives of Christian Network or are guilty of serious misconduct in connection with performance hereunder, or materially breach provisions of this Agreement, Christian Network at any time may terminate this engagement immediately and without prior written notice.

Duties and Term

For additional Christian Network project or services, duties, term of engagement, compensation and provisions for payment shall be documented by Schedule A: Project/ Service Assignment Agreement(s).

Written Reports

You may request an up-to-date report on services per this agreement. Such reports shall be in such form and setting forth such information and data as is reasonably requested by you.

Creativity and Designs

Any and all sites, logo's, designs, discoveries, developments and innovations conceived by Christian Network during this engagement relative to the duties under this Agreement shall be the exclusive property of Christian Network until project is complete and signed over to you or to a written assigned representative from your ministry, organization, or business. You hereby assign all rights, title, and interest in the same to Christian Network for advertising, marketing, resource, and publishing purposes.

Confidentiality

Christian Network acknowledges that during our engagement we will have access to and become acquainted with various trade secrets, inventions, innovations, processes, information, records and specifications owned or licensed and/or used in connection with the operation of your ministry, organization, or business including, without limitation, ministry, organization, or business and product processes, methods, customer lists, accounts and procedures. This information will be kept confidential.

Independent Client

This Agreement shall not render you or a representative of your ministry, organization, or business an employee, partner, agent of, or joint venture with Christian Network for any purpose. You will remain an independent client in your relationship to Christian Network. Christian Network shall not be responsible for taxes with respect to compensation hereunder. No claim against Christian Network hereunder or otherwise for provided design of logo, web site, invitational cards (business card), forms or letterhead or any other product/ service created by Christian Network.

Fees

An initial fee of **\$1,500.00 US dollars** is required to acquire the visionary design service of Christian Network. This may include the design of your logo, name, website, hosting, domain, invitation cards, letterhead, donation packages, or any other product / service created by Christian Network. If additional work is requested or required, payment is expected in a timely manner to proposed product/ service of any kind. A fee will be assessed for late payments of 30 days and thereafter or non- payment with an assessed 12% fee.

Insurance

Christian Network is not the responsible for professional designs after they are released from Christian Network and is not indemnified by Christian Network.

Choice of Law

The laws of the state of Illinois shall govern the validity of this Agreement, the construction of its terms and the interpretation of the rights and duties of the parties hereto.

Arbitration

Any controversies arising out of the terms of this Agreement or its interpretation shall be settled in Illinois in accordance with the rules of the American Arbitration Association, and the judgment upon award may be entered in any court having jurisdiction thereof.

Headings

Section headings are not to be considered a part of this Agreement and are not intended to be a full and accurate description of the contents hereof.

Waiver

Waiver by one party hereto of breach of any provision of this Agreement by the other shall not operate or be construed as a continuing waiver.

Assignment

No rights shall be assigned under this Agreement, or delegate the performance of any duties hereunder, without the prior verbal consent of Christian Network.

Notices

All notices and/or modifications to this agreement shall be in writing from you and/ or Christian Network sent via mail or e-mail and dated.

Modification or Amendment

No amendment, change or modification of this Agreement shall be valid unless in writing signed by the parties hereto.

Entire Understanding

This document and any exhibit attached constitute the entire understanding and agreement of the parties, and any and all prior agreements, understandings, and representations are hereby terminated and canceled in their entirety and are of no further force and effect.

Unenforceability of Provisions

If any provision of this Agreement, or any portion thereof, is held to be invalid and unenforceable, then the remainder of this Agreement shall nevertheless remain in full force and effect.

If you would like to add to the project with an additional project or service, you will contact Christian Network immediately for further consultation. You may be asked to add 20% to your additions if it interferes with work already in progress with Christian Network.
